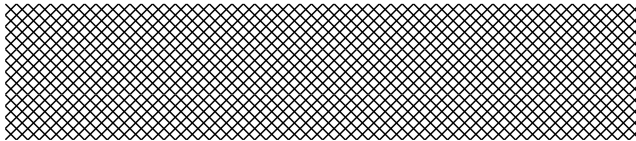

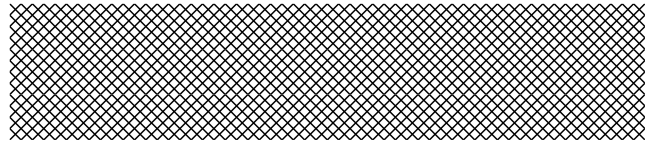

Communism played a major role in shaping the 20th century, and the remaining communist regimes still play an important role in global politics. Especially with the rise of China, pronouncements of the end of the communist era seem short-sighted. Rather, communism is a political project that, despite the collapse of the Soviet Union, has proven to be enduring and continues to challenge the „free world“. And not only in the form of military tensions, for example between the US and China, or nuclear threats from North Korea. Communist regimes offer alternative paths, for example in terms of distributive justice (see Venezuela or Cuba) and distance themselves from Western ideas of modernity (seen as compromised by colonialism by promoters of China's Belt and Road initiative). The „socialist experiment“ therefore still has appeal and resonance.

Against this background, it still seems crucial to analyze communist regimes from a political science perspective. Yet comparative political science is only marginally concerned with communist systems. The question of what actually constituted and still constitutes communist systems in Asia or Cuba, for example, has been all too hastily abandoned in favor of questions of system transformation and/or democratization. The conference aims to close this gap both synchronically and diachronically. Following the still influential paradigm of „varieties of capitalism“ in comparative politics, the conference will attempt to trace the increasing internal differentiation of the „communist world“ over time. These differences can

be explained primarily along two dimensions: temporality and informality. On the one hand, the importance of the first dimension of temporality is suggested by research on authoritarianism, according to which the time at which regimes seize power has a far-reaching influence on their character. On the other hand, communist systems have undergone considerable evolution in the course of their nearly 100-year history, both in terms of political repression (see, for example, de-Stalinization in the Soviet Union and the Eastern Bloc states, or the reform and opening-up in the People's Republic of China) and in terms of economic policy (ranging from forced collectivization or war communism to market reforms allowing coordinated market competition). The second dimension of informality is particularly important because, despite similar institutions and constitutions, the communist systems in the Eastern bloc differed greatly in the political practice of exercising power precisely because of the necessity of adapting to local conditions via unique different informal practices.

The experts gathered in Chemnitz will examine how communist systems differed and continue to differ from other forms of authoritarianism, and from each other in terms of a range of geographical and historical perspectives.

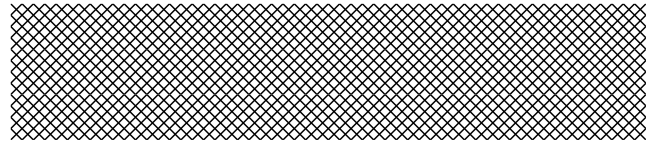
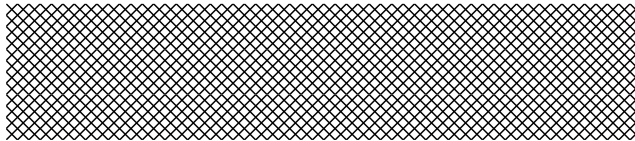
